**\$.50** with valid NJ TRANSIT monthly bus or River LINE pass at connecting stops with a ①.

**\$.50** to purchase transfer to NJ TRANSIT bus, River LINE, or the B2 for a one-way ride.

**Free** for children under 6 accompanied by adult.

### POLICIES

- A route deviation of 1/8 of a mile off the route may be requested. A route deviation reservation is required by calling Customer Service (856-461-1806) by 4:00 pm the day before travel.
- Service is curb to curb. Drivers cannot exit the bus.
- Bicycles are permitted on rack in front of the vehicle. Rack holds 2 bicycles.
- Shoes and shirts required.
- Pets, smoking, eating, littering or loud music not permitted.
- Harassment of other riders or driver, or profanity will not be tolerated.
