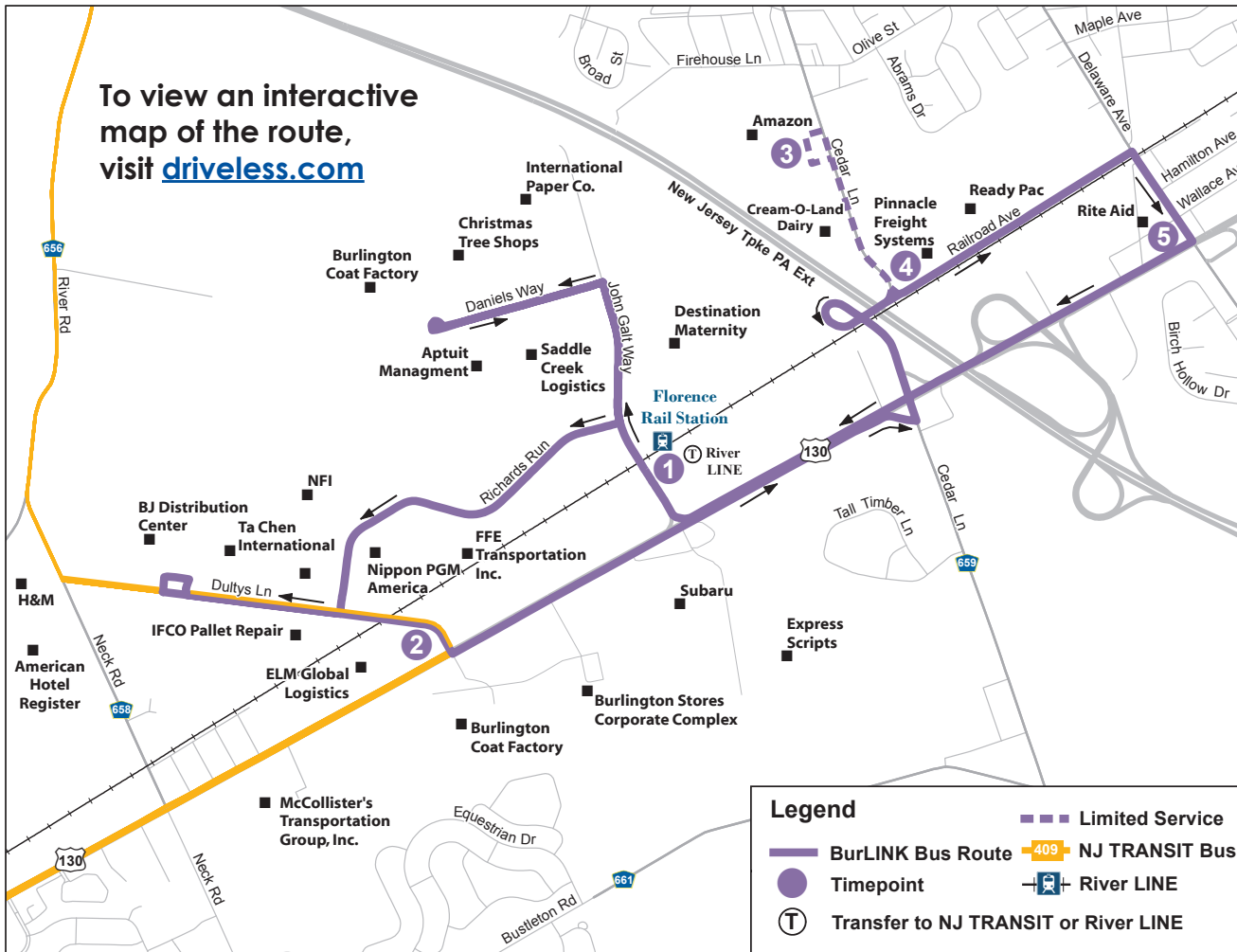

## FARES

\$2 each way. Exact fare required.

**Free** with valid transfer purchased on connecting NJ TRANSIT bus, River LINE, or B1.

\$.50 with valid NJ TRANSIT monthly bus or River LINE pass at connecting stops with a Ⓣ.

\$.50 to purchase transfer to NJ TRANSIT bus, River LINE, or the B2 for a one-way ride.

**Free** for children under 6 accompanied by adult.

- Service animals and portable oxygen tanks permitted.
- Timetable available in alternative formats.

## POLICIES

- A route deviation of 1/8 of a mile off the route may be requested. A route deviation reservation is required by calling Customer Service (856-461-1806) by 4:00pm the day before travel.
- Service is curb to curb. Drivers cannot exit the bus.
- Bicycles are permitted on rack mounted on front of vehicle. Rack holds two bicycles.
- Shoes and shirts required.
- Pets, smoking, eating, drinking, littering or loud music not permitted.
- Harassment of other riders or driver, or profanity will not be tolerated.
